Provisioning WAN Lines for Remote Access Concentrators

his guide describes how to provision WAN lines for Remote Annexes and Remote Access Concentrators (RACs). It is written for experienced users who plan and order T1/E1 Channel Associated Signaling (CAS) and T1/E1 PRI ISDN lines.

Overview

The type of line provisioning you require depends on the product that you are installing. <u>Table 1</u> shows the supported products and the line types.

Planning

Start planning your line provisioning requirements and order the lines so you have telco service when the equipment is installed. To plan line provisioning:

- Contact the telco and ask what type of switch they will provide for your line.
- 2. Ask what type of service is available to you.

Typically the telco will have Channelized and ISDN lines.

- Decide which service you want to use (CAS or ISDN). The service you select depends on the product you are installing, the services available in your area, and the type of callers you will support.
- 4. Decide the number of lines (see <u>Table 1</u>).

The Model 5399 and Model 8000 can use two lines and can use two different services (one on each WAN port).

5. Order the line(s).

Switch Types and Switch Parameters

When negotiating service from the telco you must use switch types and switch parameters supported by Bay Networks.

Switch Types

The switch types that you may use are based on the country or telco service area. <u>Table 2</u> and <u>Table 3</u> list the supported protocols and switch types.

Switch Parameters

The switch parameters that must be used are determined by the telco and the service that you select. <u>Table 4</u> lists the switch parameters supported by Bay Networks.

	A string indicating the type of busy signal to transmit when a DS0 is busied out. Valid values are $00, 01, 10, $ and 11 . The default is 11 . These apply to the a and b bits of a CAS frame -10 turns on the a bit, a 01 turns on the a 10 turns on both bits, a 10 turns off both bits.
local_phone_number	(CAS interfaces only)
	The telephone number of the RAC. Usually, this number is assigned by the switch. However, for some CAS protocols, such as R2, the number must be specified via the local_phone_number parameter.
auto_busyout_enable	(CAS interfaces only)
	Determines whether or not the RAC busies-out remaining DS0 channels when the last available modem has been used (e.g., because modems have failed or you have fewer than the maximum number of modems installed). Valid values are y (busies-out DS0s) or n (does not busy out DS0s). The default is n .
	If you leave this parameter disabled, you lose calls when there are fewer modems than DS0s. However, if you enable this parameter, a busy signal is delivered to the user and a syslog is generated to notify you of the event.
	Once you busy out DS0s, they remain busied-out until the RAC is rebooted, or until you issue the CLI superuser wan unbusyout command.
