



- Do not touch the tape surface with your fingers.
- Do not disassemble The Bank tape cartridge—such an attempt may damage the cartridge and/or The Bank mechanism.
- Moisture may condense on the tape if the cartridge is brought into a warm room from the cold outdoors during the winter. This moisture may cause damage to the tape or The Bank mechanism. Let the cartridge warm up to room temperature before using it.

STORAGE INSTRUCTIONS:

- Insert the cartridge into its protective sleeve during storage.
- Use the removable adhesive labels on the other side of this sheet for title entry and library control.
- The cartridge is provided with a break-out lug on its bottom corner to prevent accidental erasure. By breaking
 off the lug at its base, you can protect an important recording from accidental erasure. If you want to use the
 cartridge for recording again, cover the hole with a piece of cellophane tape.
